I would like to inform you that Caroline Atkinson, our Head of Global Public Policy at Google, will be in Brussels on Wednesday 18th and Thursday 19th of May 2016, and if Commissioner Thyssen agenda would allow it, it would be terrific if we could organize a meeting to discuss the forthcoming Google initiatives around jobs and digital skills.

Caroline Atkinson has joined Google few weeks ago as the new Head of Global Public Policy. In her role, Caroline advises Google's leadership on policy issues and leads Google's work with policy makers, government officials, and key political stakeholders.

Prior to joining Google, Caroline served as President Barack Obama's Deputy National Security Advisor for International Economics. As the President's senior international economic advisor, Caroline attended major international economic summits with the President and coordinated the policy-making process for international economic affairs. During her tenure, she led US delegations at G8 and G20 summits, and helped to drive global agreement on a diverse set of issues, including global trade, employment, climate change and the response to the Ebola crisis.

Before working directly for President Obama, Caroline held senior roles at the International Monetary Fund, the U.S. Treasury Department, and the Bank of England, and worked as a journalist for The Washington Post, The Economist, and The Times of London. She holds a B.A. in politics, philosophy and economics (PPE) from Oxford University.
