Information/allegations

On 2 October at 20:00LT, JRCC of Piraeus was informed that Text Removed - Justification 5 during her navigation from Rhodes to Megisti, suffered a crack near the prow (bow), so that the water started to coming in. A SAR operation was launched under the coordination of JRCC Piraeus with the participation of Text Removed - Justification 5 and two passing by vessels. After assessment of the situation Text Removed - Justification 2,4, Text Removed - Justification 5 entered the Turkish territorial waters and kept navigating towards Megisti close to the shore. JRCC Piraeus informed MRCC Ankara accordingly and Text Removed - Justification 5 was approached and escorted by TCG until Greek territorial waters. Soon after the Text Removed - Justification 5 entered the Greek territorial waters, Text Removed - Justification 5 and Text Removed - Justification 5 took over responsibility and escorted Text Removed - Justification 5 to Megisti's port.

Measures

A SAR operation was launched by JRCC Piraeus with the participation of Text Removed - Justification 5 and private fishing boats.
