Here is a brief summary of the meeting yesterday evening.

Present: Juhan Lepassaar, Laure Chapuis (CAB-Ansip), Renate Nikolay (CAB-Jourova), Pauline Rouche (CAB-Juncker), Thomas Zerdick (CAB-Timmermans) + 1 other Cabinet person (not sure who) + me

1. Juhan explains that VP Ansip wished to send a political letter to DE on the main concerns we have on the draft law; [REDACTED] Rechtsberatung
2. Renate wished that this letter should go out before the HLG meeting next Wednesday on the CoC, ideally on Monday.
3. Juncker/Timmermans/Jourova do not want to co-sign the letter, but Jourova CAB will double check.
