[REDACTED] I thank you warmly for the most appreciated meetings and guidance we received from you during our meetings in Kiev last week.

Please forgive me for my perhaps less diplomatic evaluation of the evolving situation in Ukraine from a humanitarian and health perspective. Of course we are ready to accept your corrections and adaptations to our concept note that we just presented to the appropriate authorities in EU Brussels and to several senior IGO and NGO representatives inside and outside Ukraine. Please do not hesitate to provide us with your comments and guidance.

We are impressed by the dedication and personal sacrifice of many individual persons in Ukraine to help their fellow citizens. In particular we have taken note of the inspiring opinion of these civic society leaders that the current crisis may lead to a re-birth of Ukrainian society with a strong focus on transparency, correctness and opportunity to serve others instead of self-interest. Ukraine has a great potential to grow economically, politically and socially; the depth of sorrow and concern may lead the way to shared prosperity and happiness as never seen before.

Therefore and on that basis our concept-note seeks to both identify and operate

actionable projects in the short and in the longer term. Implementation can be reached through a multi-stakeholder all-inclusive public/private partnership approach.

The PA International Foundation has acted effectively and practically in 6 earthquakes and 3 tsunamis, usually in direct coordination and cooperation with UNICEF, WFP, Medecins Sans Frontieres, and key important and reliable local NGOs and civic society leaders. We have acted in an early multi-stakeholders embracing support-role in China, Japan, Pakistan and Indonesia and we have contributed to humanitarian oriented law and regulatory adaptation projects in the Middle East/Gulf, throughout Asia and in the European Union. Our proposals are based on prior experiences or current projects including a major WFP/Royal DSM micro-nutrient investment project in Uganda.

We will be honoured and pleased to provide our experience and networks to you and we hope that the European Commission and perhaps the US Government will be able and willing to help us doing this.

Your guidance and support are of crucial importance for the convening of the High Level Multi-Stakeholder Roundtable Conference that we hope to be able to organise as soon as possible in Berlin to identify actionable projects and have optimal coordination and cooperation among all parties.
