Dear Ms Izuzquiza,

We refer to your application in which you make a request for public access to documents, registered on **17 September 2021**, under the above reference number.

In your application, you request access to the following:

After a thorough examination of your application for access to documents pursuant to Regulation No. 1049/2001, FRA has reached the following conclusions:

Full disclosure

Concerning documents 4a4, 4a7, 4a17, 10a, 14b, 14c, 16b, 16e, 17o, 18d, 22b, 31a, and 33a, our examination concluded that they can be disclosed. You can find them attached. **Document 34a** is already in the public domain in its final version, you can find it at the above indicated link.

II. Partial disclosure

A. Pursuant to Article 4(1)(b) (protection of the privacy and the integrity of the individual)

Concerning documents 1, 1a, 2, 2a, 3, 4, 4a1, 4a2, 4a3, 4a6, 4a8, 4a9, 4a10, 4a11, 4a12, 4a13, 4a14, 4a16, 5, 6, 6a, 6b, 7, 9, 10, 11, 13, 14, 15, 15a, 16, 16a, 16c, 16d, 16f, 17, 17l, 17p, 18, 21, 22, 22a, 24, 24a, 25, 28, 29, 31, 32, 33, 34, 36, 46, 46a, 47, 47a, 48, 49, 50, 51, 52, 53, 54, 55, and 56, our examination concluded that they can be partially disclosed. You can find them attached in their expunged version.

Following a thorough examination of these documents, some parts need to be blanked out due to the exceptions set out in Article 4(1)(b) (protection of the privacy and the integrity of the individual):

Pursuant to Article 4(1)(b) of Regulation (EC) No 1049/ 2001, partial access to the documents requested can be granted. The expunged parts cannot be disclosed as they would undermine the protection of privacy and the integrity of the individual, in particular in accordance with legislation regarding the protection of personal data. The applicable legislation in this field is Regulation (EC) No 2018/ 1725 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

When access is requested to documents containing personal data, Regulation (EC) No 2018 / 1725 becomes fully applicable. According to Article 9(1)(b) of this Regulation, personal data shall only be transferred to recipients if they establish "(...) that it is necessary to have the data transmitted for a specific purpose in the public interest and





the controller, where there is any reason to assume that the data subject's legitimate interests might be prejudiced, establishes that it is proportionate to transmit the personal data for that specific purpose after having demonstrably weighed the various competing interests. "

We consider that, with the information available, the necessity of disclosing the aforementioned personal data to you has not been established and that it cannot be assumed that such disclosure would not prejudice the legitimate rights of the persons concerned. Therefore, we are disclosing the documents requested expunged from this personal data.

If you wish to receive these personal data, we invite you to provide us with arguments showing the necessity for having these personal data transferred to you and the absence of adverse effects to the legitimate rights of the persons whose personal data should be disclosed.

B. Pursuant to Article 4(1)(a) (public interest as regards public security)

Concerning **documents 4a8, 4a15, and 4a16** some parts have also been expunged following the exception laid down in Article 4(1)(a) as their disclosure would undermine the public interest as regards public security, since they include pictures of restricted areas and/or sensitive information. You can find the documents attached in its expunged version.

C. Pursuant to Article 4(3)(2) (opinions for internal use as part of deliberations and preliminary consultations)

Concerning **documents 9, 9b, 10, 17p, 49, and 50** some parts have also been expunged following the exception laid down in Article 4(3)(2) of the Regulation.

Disclosure of these parts of documents would undermine the protection of the decision-making process of the agency, as they contain opinions for internal use and are part of deliberations and preliminary consultations. The FRA must be free to explore all possible options in preparation of a decision free from external pressure. The second subparagraph of the said Article 4(3) provides that, after a decision has been taken, the exception at issue covers only documents containing opinions for internal use as part of deliberations and preliminary consultations within the institution concerned. Therefore, the exception laid down in Article 4(3)(2) of Regulation (EC) No 1049 / 2001 applies to this document. After a careful assessment, FRA does not see any overriding public interest to release this document.

III. Non disclosure

Having carefully examined the documents requested under the provisions of Regulation (EC) No 1049/ 2001 regarding public access to documents, FRA regrets to inform you that disclosure of the above-mentioned documents is prevented by exceptions laid down in the Regulation.



Concerning documents 3a, 5a, 7a, 7b, 7c, 8, 8a, 9a, 12, 14a, 18a, 18b, 18c, 19, 19a, 20, 23, 23a, 23b, 23c, 23d, 23e, 23f, 23g, 25a, 25b, 25c, 26, 28a, 30, 32a, 32b, 32c, 32d, 32e, 35, 37, 38, 39, 40, 41, 42, 43, 44, 45, 47b, 47c, and 47d, the disclosure is prevented by the exception laid down in Article 4(3)(2) of the Regulation.

Disclosure of these documents would undermine the protection of the decision-making process of the agency, as the documents contain opinions for internal use and are part of deliberations and preliminary consultations. The FRA must be free to explore all possible options in preparation of a decision free from external pressure. The second subparagraph of the said Article 4(3) provides that, after a decision has been taken, the exception at issue covers only documents containing opinions for internal use as part of deliberations and preliminary consultations within the institution concerned. Therefore, the exception laid down in Article 4(3)(2) of Regulation (EC) No 1049 / 2001 applies to these documents. After a careful assessment, FRA does not see any overriding public interest to release this document.

However, the content of these draft documents is reflected in the disclosed final documents.

Finally, concerning documents 17c, 17d, 17e, 17f, 17g, 17i, 17k, 17m, 17n, 29a, and 36a, these are currently under consultation, and the Agency is closely working with the parties involved. As soon we address this consultation you will receive a follow up response.
