I. INTRODUCTION AND OBJECTIVE

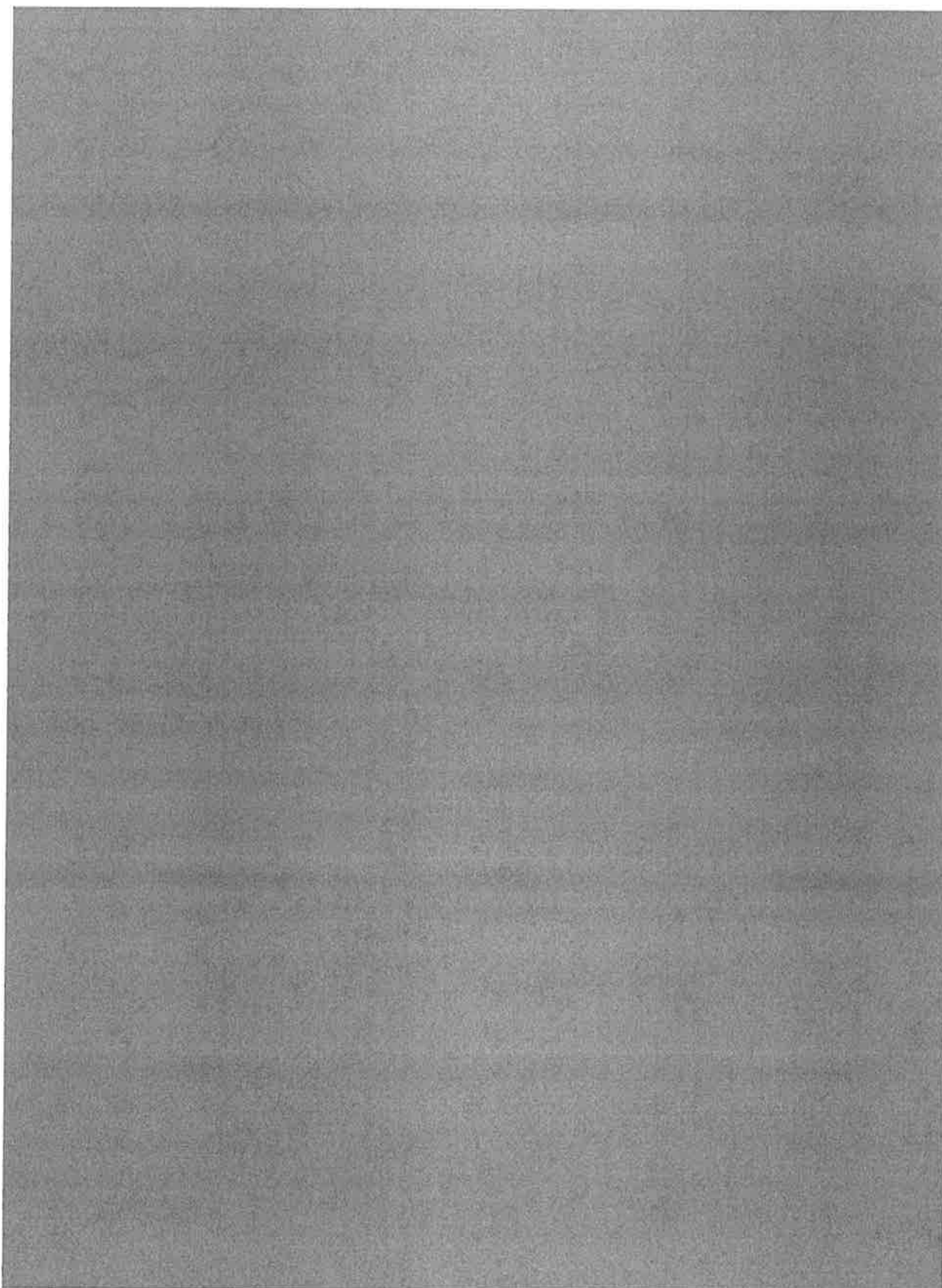
1. EUNAVFOR MED Operation SOPHIA (hereinafter ENFM), the Libyan Navy/Coast Guard (hereinafter LN/CG) and the Ministry of Defence of the Republic of Croatia (hereinafter HR MOD), each referred to herein individually as a "Participant" and together as the "Participants";
2. Bearing in mind Decision of the Council of the European Union 2016/993 of 20 June 2016 which, while retaining the focus on ENFM core mandate, added two further supporting tasks, in particular capacity building and training of, and information sharing with, the LN/CG;
3. Recalling the Decision of the Council of the European Union 2017/1385 of 25 July 2017 to extend the mandate of EUNAVFOR Med Operation Sophia until 31 December 2018;
4. Taking into consideration the Memorandum of Understanding between ENFM and The LN/CG signed on 23 August 2016 regarding training of the LN/CG (hereinafter "the MOU") in order to improve security of the Libyan territorial waters and enhance LN/CG in law enforcement tasks at sea, particular to prevent human smuggling and trafficking;
5. Recalling the letter of the ENFM Operation Commander of 19 December 2017 to the Chairman of the EU Military Committee (CEUMC) inviting, among other, Member States to revisit their interest in providing training to the LN/CG within the training package 2 (TP2);
6. Recalling the letter of the Chief of the General Staff of the Croatian Armed Forces 4 July 2018 expressing intent of the Republic of Croatia to contribute to the LN/CG TP2.;
7. Hereby jointly decide the following terms and provisions, concerning the implementation of the training module of the TP2 phase as stated in this Technical Arrangement (hereinafter "the Arrangement").

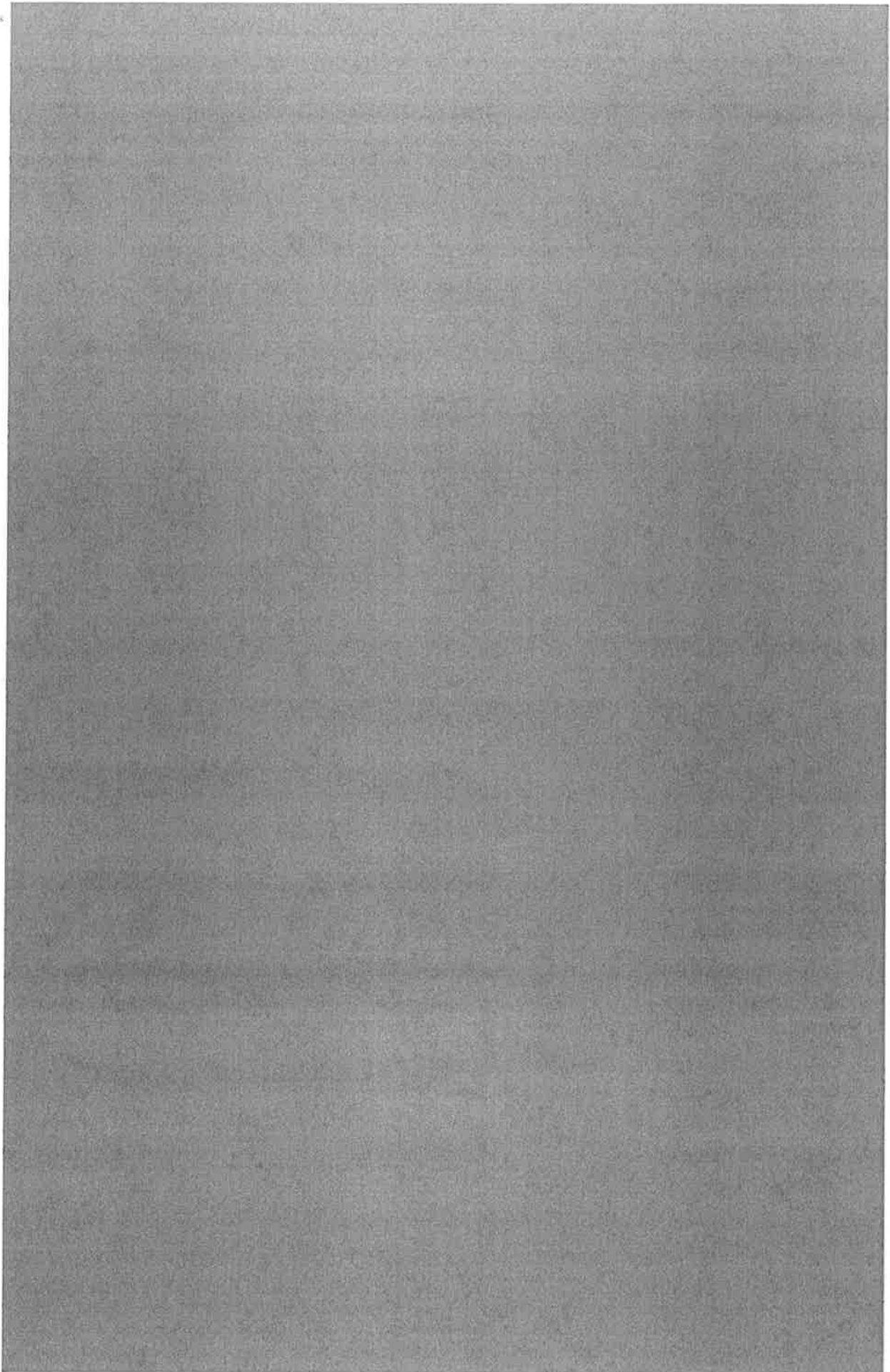
II. DEFINITIONS

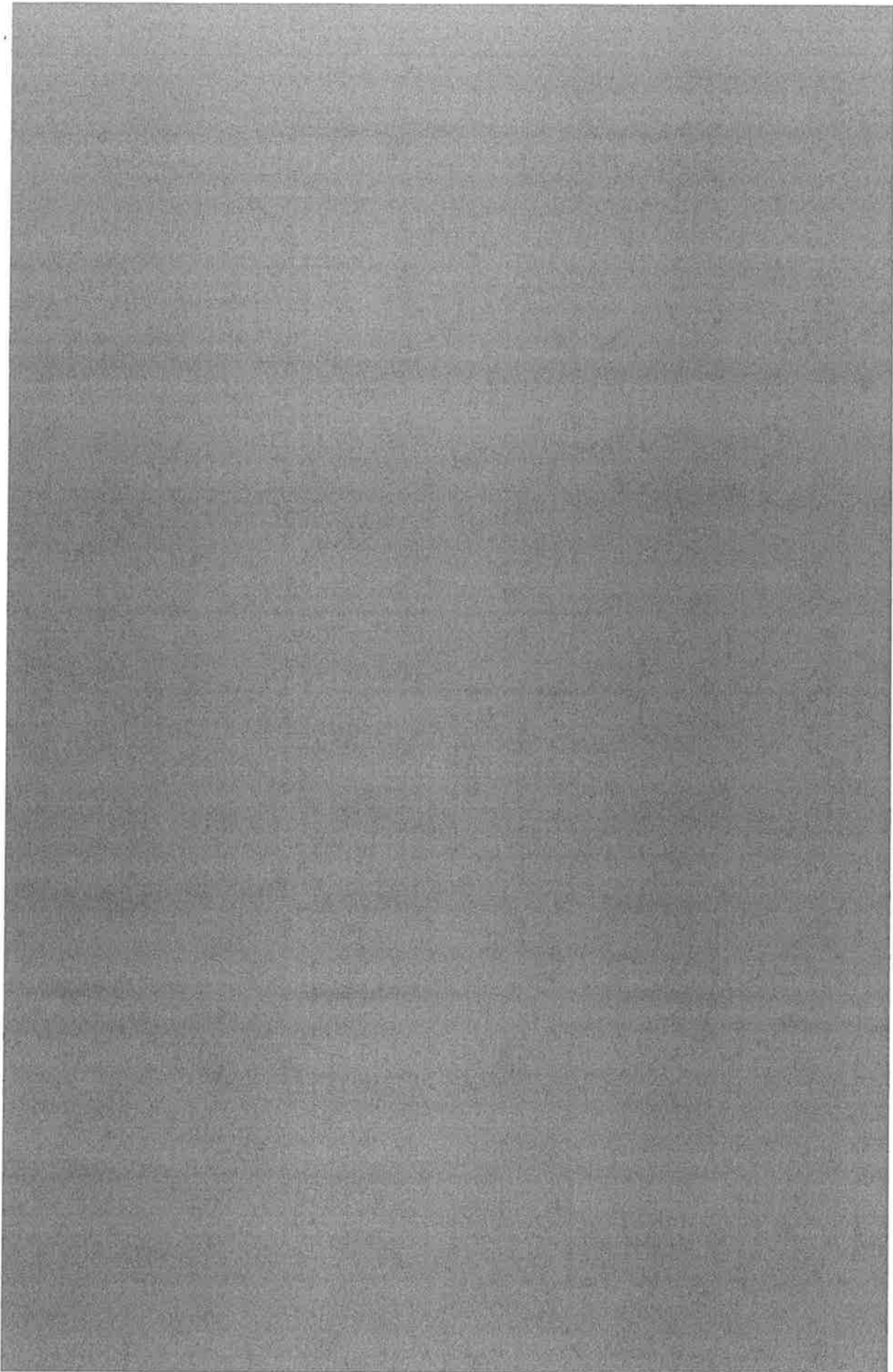
In addition to any terms defined in other provisions of this Arrangement, the terms below reported will have the following meanings when used herein:

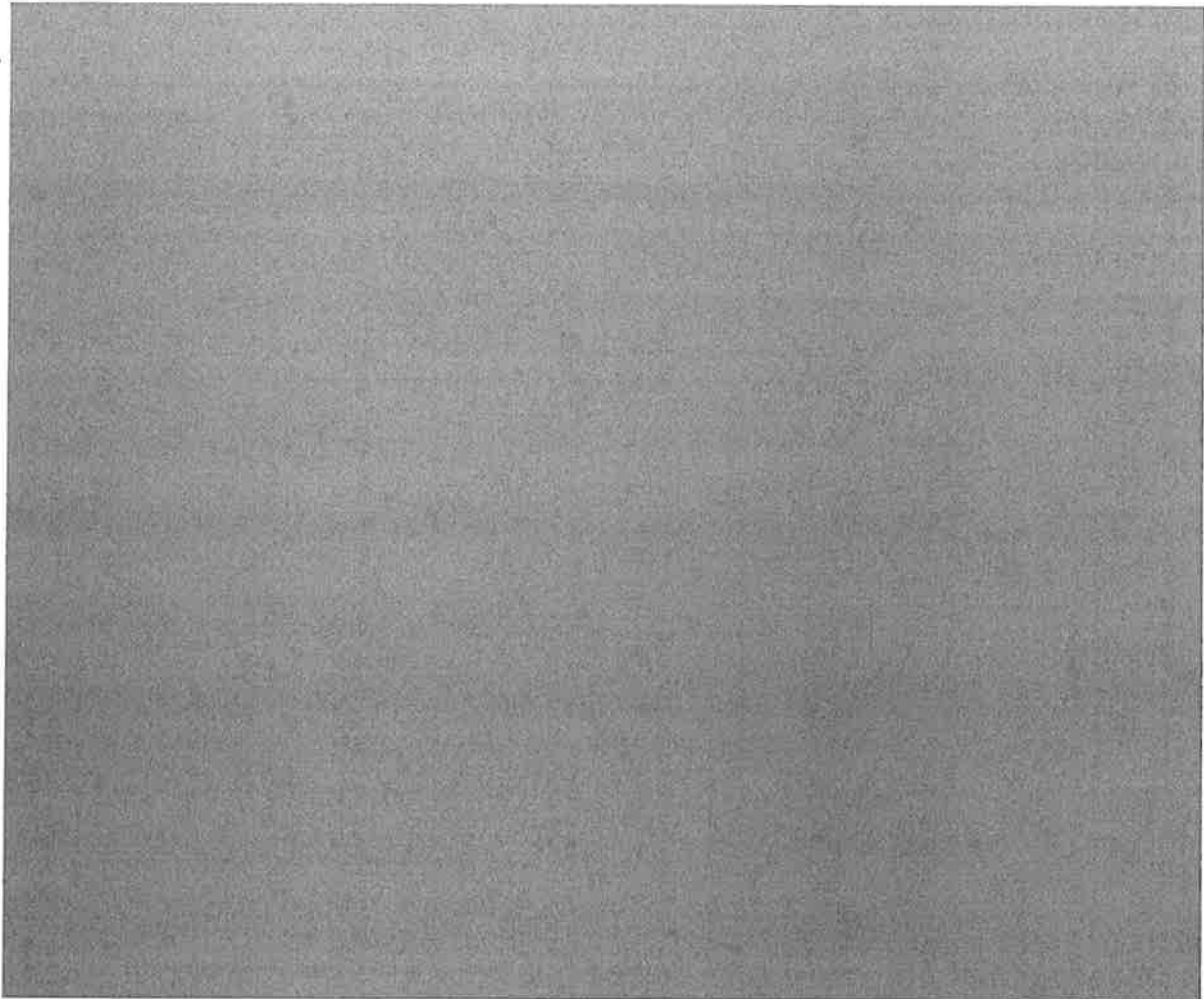
1. "Committee of Experts (CoE)": as defined by Decree No 7/2016 issued by the Minister of Defence of Libya, a Committee appointed to liaise with ENFM in order to implement the training programme;
2. "Senior Officers Team" (SOT) means a team composed of ENFM experts appointed to liaise with the Libyan CoE;

12. Upon successful completion of each training package, each Trainee will receive a certificate of attendance which will be issued by ENFM.
