Purpose of the meeting:

From the EU side:

- Reconfirm the EU's appreciation for ICMPD in its supporting role in migration dialogues
- Confirm that managing migration remains one of the key political priorities of the Commission. Building on the progress made so far, we need a fresh start to overcome the current legislative stalemate and equip the Union with a system capable of managing migration in all its different forms in a sustainable manner.
