Dear Maciej,

Following our phone exchange on Friday, I am sending you here below some of the (provisional) details of the AGRI committee mission to the Polish border with Ukraine on 20-21 June, thanking you already in advance for your availability to help us ensuring a fruitful mission to our MEPs.

The AGRI committee is envisaging a fact-finding mission on the Polish-Ukrainian border, on 20-21 June. This mission would take place in the context of the Solidarity Lanes recently presented by the EC.

With a view to evaluating import of Ukrainian agricultural commodities and the potential for alternative routes, the parliamentary delegation would visit the border crossing points at **Medyka** (road) and **Przemyśl** (rail). In order to assess the storage capacities of agricultural products, AGRI Members would also meet with some professionals involved (possibly the Grain and Feed Chamber: **Izba Zbożowo-Paszowagospodarcza**).

I would be grateful to you for any suggestion aimed at making the visit as informative as possible. I would also be grateful if you would assist us with our contacts with the competent Polish authorities, so as to facilitate the preparation and smooth-running of the visit.

I remain available to discuss all this further as soon as you can.
